Community Against Violence invites you to submit your artwork for acceptance into the **Taos Summer Arts & Crafts Fair, August 10, 11 & 12, 2018 at Kit Carson Park, Taos, New Mexico.**

This is a unique event during the summer tourist season that blends the incredible artistry of Taos with a deeply important cause and call to action. Having received overwhelmingly positive responses from past participating artists we will continue to grow this year's fair, expanding our reach to new artists and attendees alike. To do so we will maintain listings of the festival in Taos and New Mexico events calendars, newspapers, radio announcements and oversee a social media ad campaign to directly capture our target audience.

Our goal is to make this a highly visible, high quality, and highly profitable fair for all our participants.

Booth fees will be used to promote the fair and support Community Against Violence, which provides crisis intervention, support, shelter, and advocacy to victims of domestic violence and sexual assault, and their children in Taos County.

**ACCEPTABLE ARTWORK:** Original works of art in all media will be considered. Absolutely no imported, manufactured, mass-produced items, kits, or items not made in total by the exhibitor will be allowed. Please send good quality photos, slides or website link representative of your work with your name on each one. The jury will judge your work on originality, creativity and superior craft to ensure a high-quality event and wide diversity. Organizers will check to ensure that work exhibited is the same quality as the original juried pieces.

#### **APPLICATION PROCESS AND TYPES (NEW):**

- **This year we are also offering two alternative applications:**
  - New Artist/Vendor Incubation Application: This application is for artists who are brand new to fairs and their work and in need of a reduced fee
  - Student Application: Any student of high school age or above who is interested in selling their work and in need of a reduced fee
- If applying as a student or new artist you will receive a phone call to review your application, followed by an email with the decision and your adjusted fee.
- Complete the attached **Application and Agreement to Exhibit.**

Complete the attached **Town of Taos Special Business Registration.** A one-time fee of \$10.00 made payable to the Town of Taos will need to be included with this registration form for the calendar year 2018.

**A completed application is required for each show even if you have paid the yearly fee.**

- All Special Business Registration applicants must possess a valid New Mexico CRS number from the State of New Mexico Taxation & Revenue Department – applications without a number will not be accepted.
- All food vendors must possess a valid Food Certificate from the State of New Mexico Environment Department.
- All food vendors working with propane will be inspected by the LP Inspector of the State of New Mexico.
- All **FOOD** vendors shall be inspected by the Fire Department – (\$25.00 fee to Town of Taos) 575-751-2000.  
*If you are a food vendor, please attach a check for \$25.00 for the inspection.*

Section 5.08.020 Special Business Registration Required

It is unlawful for any person to engage in business, operate a booth or stand, or sell goods and/or services during any fiesta, carnival or festival within the town limits without first obtaining a special business registration from the town. **Special business registration fees are ten dollars (\$10) for each vendor, booth or stand, and shall be prominently displayed at each booth, trailer or stand. The registration will expire on December 31 on the year issued.** (Ord. 97-53 §1, 1997; Ord. 94-7, 1994; prior code §18-131)

Section 5.08.040 Food and Drink Purveyor's Permit Required

It is unlawful for any person to sell any food or drink during any fiesta, carnival or festival within the town limits without first obtaining a food and drink purveyor's permit from the New Mexico Environment Department. **Such permit shall be prominently displayed at each booth, trailer or stand.** (Ord. 97-53 § 1 1997; Ord. 94-7, 1994; prior code § 18-133)

Section 5.08.040 Taxation and Revenue Permit Required

It is unlawful for any person to engage in business, or offer for sale any goods or services within the town limits, without first obtaining a tax number from the New Mexico Taxation and Revenue Department, or from the town. **Such tax number shall be prominently displayed at each booth, trailer or stand.** (Ord. 97-53 § 1, 1997; Ord. 94-7, 1994; prior code § 18-133)
